




Furthermore, following the self-care guidance of our staff allows us to identify and initiate opportunities to utilize effective and lower cost medications and treatments.

Patient Case Examples

Rick is a 45 year old patient with diabetes and no additional risk factors, who takes Jardiance daily to manage his blood sugar. After his appointment with Apothicor Wellness, Rick agrees to change his medication to a cheaper alternative and follow lifestyle recommendations; this change is also accepted by his healthcare team. By following these recommendations, Rick may be eligible for an incentive of up to \$500.

Sarah is a 21 year old patient with mild asthma. She uses a generic Flovent inhaler twice daily and albuterol as needed. After her appointment with Apothicor Wellness, Sarah agrees to switch to generic Symbicort as needed, in addition to following her asthma care action plan. This change is also accepted by her healthcare team. By following these recommendations, Sarah may be eligible for an incentive of up to \$500.

Mark is a 55 year old patient with prediabetes who takes metformin daily to manage his blood sugar. After his appointment with Apothicor Wellness, Mark agrees to implement lifestyle recommendations and continue taking his metformin as directed. By following these recomendations, Mark may be eligibe for an incentive of up to \$50.


Upon submission, we will email you two additional forms to sign electronically, acknowledging the privacy of your information and your say regarding recommendations made by our staff to you and your healthcare team.

However, with nothing to lose and so much to gain, we highly recommend participation for those with any health conditions and/or those taking any medications.




Once you have submitted your HRA and signed all necessary documents, our staff will evaluate your profile and reach out to schedule a time to meet with you.



There are three primary services included when meeting with our staff:

Medication Therapy Management (MTM)

ensures your health conditions are treated with the most evidential medications available and that you comprehensively understand your drug regimen.


Cost Containment identifies uses of lower cost medications without sacrificing your health outcomes; as well as, guarenteeing the lowest possible out-of-pocket cost for you.


What to Expect Continued...
